Directions to Hunt Test Headquarters: From I-80 Exit 300 (Wood River Exit) proceed south on NE Highway 11 (also known as Prosser Rd.). Continue south about two miles – look for the Lilly Sand & Gravel Sign on the right. Turn north into the Parking Area. GPS Coordinates (Latitude, Longitude 40.739107600, -98.568040900). Physical Address 11970 W. Platte River Dr., Wood River, NE 68883

Check-in: Check will begin at 7:00 AM. Handlers meeting will be at 7:30 AM. Test will begin at 8:00 AM.

Camping: Windmill State Recreation Area is just north of the Gibbon I-80 Exit. The campground is operated by the Nebraska Game and Parks Commission (NGPC). Use the NGPC website to make reservations – (www.outdoornebraska.gov)

Lunch: Lunch will not be served on the test grounds. There are restaurants near-by – Subway at the Pilot Fuel Stop at the I-80 300 Exit. The Alda Truck Stop is 10 minutes from the hunt test headquarters, is open 24 hours, and has a great breakfast menu.

Awards Social and Banquet: The "Social" will be held on Saturday evening beginning around 6:00 PM at the American Legion Hall – 118 W. 9th St., Wood River, NE. Ribbons will be awarded to dog/handler teams that passed on Saturday. A raffle and auction will also be held with lots of nice items.
