Directions from Farmington, NM

Take US-64 East thru Bloomfield, about 21 miles from Bloomfield, and 2 miles past the town of Blanco, turn left onto NM-511 (well marked at mile marker 76). In 8 miles is the intersection with NM-173 (a Sinclair gas sign is at the corner), which is where the community of Navajo Dam is located (and Abe's). Continue on NM-511 along the San Juan River, the Simon Point Day Use Area is about 2 miles on the left, the turn-off is marked.
