Please keep your dog on lead at all times, unless the dog is running a test, and please air your dog in appropriate areas.

Conowingo HRC Officers, Directors, and the landowner assume no responsibility for exposure to COVID-19, loss, damage or injury to participants, spectators, their dogs, or property.

COVID-19 Information:

- COVID-19 restrictions are currently easing, but previous restrictions may return, which could result in the cancellation of the event. Should the event be cancelled, entry fees will be refunded minus fees charged by Hunt Secretary.
- All in attendance at the hunt test are attending at their own risk and are asked NOT to attend if they, or their immediate family, have symptoms of COVID-19.
- All handlers are responsible for following the current CDC guidelines in the state of Maryland, and for use of Personal Protective Equipment (PPE), including proper use of masks, gloves, and sanitizing products, and for maintaining required social distance.
- ALL HANDLERS AND JUDGES ARE RESPONSIBLE FOR BRINGING THEIR OWN PPE: including masks, gloves, and sanitizing products. Due to shortages, none will be available except to club workers. Judges and Marshalls should bring their own pens & pencils if they do not wish to use the ones provided by the club.
- Vehicles should be parked with sufficient distance between them to ensure social distancing. Please avoid congregating and avoid touching dogs that are not under your direct supervision.
- No large galleries or gathering in the judge's area will be permitted.
- Handlers should remain with their vehicles when possible, and only come to the holding blind when called.
- CHRC requests that all person's present be respectful of others' concerns.
