DIRECTIONS TO HUNT TEST AREA:

August A. Busch Memorial Conservation Area
2360 Highway D, St. Charles, MO 63304

From the intersection of Interstate Highway 64 (Missouri Highway 40/61) and Missouri Route 94 proceed west on Route 94. When you get to Highway D turn right, and then proceed to the entrance of the conservation area on the right. Signs for each stake will be clearly posted once you enter the property.

The hunt test headquarters will be at the stables, although all check-in, bitch check and ribbons will be done at the individual stakes. If you need to talk with someone at headquarters, upon turning into Busch turn right at the first stop sign, and then take the next left. Stable is on right.
