NO PHONE OR FAX ENTRIES WILL BE ACCEPTED. There must be a separate and complete entry form for each dog entered. **Entry Deadline is November 13th, 2020.** Non UKC registered dogs are required to pay an additional \$5 per entry per day. Non HRC, Inc. members are required to pay an additional \$5 for each entry in the seasoned & finished categories. Please be sure to add the additional fees if appropriate. *To be included in the program, we must have your entry by November 13th, 2020.* **Make checks payable to HuntSecretary.com**

SCRATCH POLICY: Refunds will be made if notice is received **before November 13th, 2020.** Full refunds for injured dogs or a bitch in season are **subject to receipt of a veterinarian certificate** submitted to the Hunt Test Secretary by **December 4th, 2020.** A bitch in season is prohibited from participating in the test and being present on the test grounds. There will be a **\$25 fee for scratches after November 13th, 2020.** A substitution after **November 13th, 2020** will incur the \$25 scratch fee. **NO REFUNDS FOR NO SHOWS.**
