**SCRATCHES:** Scratches require veterinarian's certificate. (Illness, Injury or Bitch in Season)

**To avoid disqualification for interfering with a fair testing opportunity for other dogs: EVERY bitch (even if spayed or not entered) must be checked daily at the Bitch Check Station before 9:00 am. No bitch in-season is allowed inside the entry gate unless confined AT ALL TIMES to the area between the house and barn south of the entry road.**

**REFUND POLICY:** Entry fees refunded only for (1) bitch in heat, (2) illness or injury to dog verified in writing by vet or (3) refunds made by [HuntSecretary.com](http://HuntSecretary.com) in advance of on-line registration closing.
