A full refund minus a \$20 bird fee will be given for female dogs in heat and confirmed by a bitch check during the morning of the event check-in. If not confirmed, you will not receive a refund. A full refund minus a \$20 bird fee will be given for injury, illness, or death, when certified by a veterinarian. However, no action will be taken until the Hunt Test Secretary receives a written request including: dogs name, test(s) entered, whom to make the check payable to, address to mail refund, and written veterinarian excuse on clinic letterhead and signed by the veterinarian. No refunds will be considered if not to the Hunt Test Secretary within 5 days of the completion of the test. Refunds will not be given for no shows.
